

- To organize mutual academic visits to nearby vicinities like Shelter home.


Nature of collaboration and liabilities of APOLLO COLLEGE and BHILAI

# MEMORANDUM OF UNDERSTANDING

- Second party will train the students for preparing teaching learning activities, sculptures.


## 3. IMPLEMENTATION

## 5. DURATION AND RENEWAL OF AGREEMENT

6. **AMENDMENTS**
