MEMORANDUM OF UNDERSTANDING

BETWEEN

BHILAI MAITRI COLLEGE, RISALI

AND

APOLLO COLLEGE, DURG

- 6.3 Should any disagreement arise out of the application, interpretation or implementation of this Agreement, the colleges shall endeavor to exercise best efforts to negotiate their differences.

7. TERMINATION OF AGREEMENT

This agreement may, at any time during its period of validity, be terminated by either party upon prior notice to the other party in writing not less than 1 month before termination date, provided that such termination shall not affect the completion of any program or activity underway at the time the notice of termination is given.
