

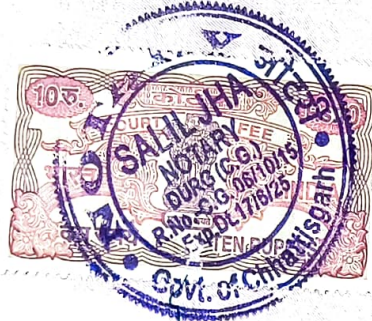

Scope of Cooperation

This memorandum of Understanding may be modified through mutual discussion and consent of both the institutions and shall remain in effect from the date of signature for an initial period
